Hi John,

I'm writing to let you know that I dropped off a Statement of Interest for the Arena Commission from Kevin Barry.

Kevin has significant experience coaching hockey at the youth level and at the high school level. He also has experience sitting on league governing boards for both youth and high school levels.

His Statement of Interest does not mention that he has a very impressive and relevant resume of business experience with renovation and building projects. Here is a summary list of the positions and projects that he has led.

- Kevin led the Multi-million dollar Budgeting and Appropriation process for Capital Improvements at the Somersworth facility.
- Kevin led the bidding and award process for facility improvements.
- Kevin managed the projects

Some of the major projects that were completed in the last 3-4 years under Kevin's leadership included:

- Renovation and rebuilding of the Hydro power co-generating station that allowed GE to generate its own power and sell excess power to PSNH
- Completed Major renovation to Engineering and office area floors including office layout, wiring, painting, carpeting and personnel movement
- Paving of the entry and parking areas serving up to 200 spaces
- Major "curb appeal" conservation project to replace windows and re-face front/side facade of building
