§ 158-3 B **Term** and Officers of Commission. The terms of the City Council and School Board Commissioners shall be commensurate with their terms of service on their respective boards. Commencing January, 2016, the eleven (11) Commissioners shall be appointed for one (1), two (2) and three (3) year terms as determined by the City Council. Thereafter, all appointments and reappointments shall be for a term of three (3) years. The Mayor shall appoint the chairman, the commission shall, from its own members, elect a secretary, and other necessary officers to serve for one year or until their successors are elected. *Mayoral Nomination /Confirm by City Council – Chair – no specific regulations – appoint each chair for term of membership.*

City Charter, Section 74: Mayor nominates subject to confirmation by Council, after Mayor nominates, Council can nominate. Ballot vote required.  
Five Regular Member Board; terms of regular and alternate members changed to 3 Year Terms in January 1984.  
Vacancies must be filled for unexpired terms, vacancies filled in accordance with Charter § 7-78 of General Ordinances. All members must be residents of the City of Rochester (RSA 673:3).
