We received your Notice of a Public Hearing on May 4, 2021, at 6:30 pm., regarding renumbering Tebbetts Road. We live at "197" Tebbetts Rd., and have been here for 23 years. If this renumbering is approved, we must then notify numerous people of our address change, including:

12 physicians, 4 hospitals, Social Security, Medicare, Church, Pension Plan, Attorneys, Investments, Banks (which will also require purchasing new check books}, Licenses, Registrations, Post Office, Credit Card Companies, Home-Health-Auto Insurances, Dentist, Waste Management, Lawn Mowing Company, Metronic Pacemaker, Home Heating Oil, Electricity, Internet and Xfinity Companies.

In addition, we must notify 30-40 family members and friends of this address change.

When we moved here we were required by the Rochester Fire Dept. to install a pole at the end of our driveway with our address number on it. We purchased and had installed a very nice granite pole and had "197" engraved on it.

Our questions would be:

- (1) Why is this Tebbetts Road address number change being proposed?
- (2) Would our mail be delivered to us in a smooth fashion, or will there be confusion in the delivery of our mail to us with a new address number?

We feel that this address number change, if approved, will indeed create a challenging job for us to notify all of the above of this change.

We have lived at this address for 28 years and DO NOT see the need for re-numbering. It can be avoided by simply requesting property owners to place numbers on their mail boxes and homes clearly visible to emergency services.

We have a few questions:

- Is the City providing financial and professional assistance to cover the expense, effort and inconvenience of the address changes required? Property deeds, vehicle titles, drivers licenses, banking institutes, utilities, health care providers, places of employment, legal fees, etc.
- Are all of the houses being renumbered or just a few? If it's just a few as I believe (Hebert and Creighton) numbering the mailbox and house is the simplest solution.
- Are all houses that are re-numbered going to receive a new number or a recycled number?
