**MINUTES**

**1. Call to Order**

Mayor Jean called the City Council Special Meeting to order at 7:25 PM. Deputy City Clerk Marcia Roddy took a silent roll call. All councilors were present, except for Councilor Lachapelle, who had been excused.

**2. Approval of a Second Hand Dealer's Renewal**

Councilor Walker **MOVED** to approve a second hand dealer's license renewal [Once Found f/k/a Craizee Collectors]. Councilor Gates seconded the motion. The **MOTION CARRIED** by unanimous voice vote.

**3. Modifications to the Granite Ridge Development Plan**

Councilor Varney questioned the proposed plan. He said there are three different dates in the chart and thought there should be some consistency in the dates.

Councilor Varney also cited the software/hardware budget that he believes to be left over from a time when it was thought that it would be paid for out of funds from the TIF revenue. He said the plan is not to do that and this item should be removed.

Councilor Varney said there are dates for new construction that have been omitted and he thinks that should be corrected.

Councilor Varney **MOVED** to remove what is now #2 and replace it with what is now #5. He said that the use of funds as stated in #2 is an inappropriate use of TIF revenue. Councilor Walker seconded the motion.

Mayor Jean asked Economic Development Manager Karen Pollard if any Economic Development [ED] funds are used for the Granite Ridge TIF. Ms. Pollard said the only funds used from the ED fund were in the creation of the plan and that was several years ago. The **MOTION CARRIED** by unanimous voice vote.

Councilor Varney said that the Public Works Department and the City Manager would be subject to recommendations by the TIF Advisory Board and they may be allowed to contract these services. He said that as long as the City Council approves of the contracted services that would be okay, the wording is not clear. Ms. Pollard said that at this time there is not a budget for what the Public Works costs would be they wanted to have both options available.

#### **4. Non-Meeting -- Consultation with Legal Counsel, RSA 91-A:2**

Councilor Walker **MOVED** to enter into a non-meeting under RSA 91-A:2 - Consultation with Legal Counsel at 7:30 PM. Councilor Gates seconded the motion.
