On February 17, 2015 a mandatory pre-bid walk-thru meeting was held along at the Granite Ridge Development District on Farmington Road (Route 11), Rochester, NH. The meeting commenced at 10:00 AM and concluded around 10:30 AM. The following is a summary of this meeting:

Tighe & Bond, gave a brief overview of the Proposed Granite Ridge Development District Infrastructure Improvements Project including a brief description of each of the three project components.

Tighe & Bond discussed the unique project coordination efforts that will be needed to complete this project including working with the Property Owner's Sitework Contractor.

Tighe & Bond then gave an overview of key components of the Project Manual as they pertain to the preparation of bids.

Tighe&Bond

Tighe & Bond stated that all questions are to be submitted in writing via the Tighe & Bond website no later than **2:30 pm on February 20**, **2015** and that only questions submitted via this process will be answered and binding.

Tighe & Bond stated that all bids are due no later than 2:15 pm on February 26, 2015 at the Finance Department of the Rochester City Hall; and that all bids would be opened at 2:30 pm that same date.

Tighe & Bond stated key dates for the project as outlined in Section 00520 of the Project Manual and the associated liquidated damages.

Tighe & Bond gave an overview of the Contractor's responsibility for obtaining permits and discussed the status of the NHDOT permit.

Tighe & Bond stated the working hours as outlined in the project manual.

The DPW stated that written notice of any modifications to the work schedule must be received in writing at least 48 hrs in advance of the work to be performed.

Tighe & Bond summarized the payment process as outlined in Sections 00520 and 00700.

Tighe & Bond invited the Bidders to ask questions. The questions are summarized below:

Q: Can the bid period be extended?

A: No. The bidding period was set by the mutually agreed upon Developer's Agreement between the City of Rochester and the property owner, Waterstone Rochester, LLC. In addition, only licensed contractors with the City of Rochester are allowed to provide water or sewer work.

Q: What permits are required?

A: Water and Sewer Connection from City of Rochester DPW. Excavation and Driveway Permit from the NHDOT are to be covered under the same permit and are pending.

Q: Will the draft NHDOT permit be issued prior to the bid opening?

A: Yes. The Draft NHDOT permit will be issued as part of Addendum No. 1.

Q: Will additional geotechnical information be provided prior to the bid?

A: No. There is no additional geotechnical information that can be provided.

Q: Will equivalent systems be allowed for the variable frequency drives (VFD) pump system?

A: VFD's must be compatible with an Allen-Bradley programmable logic controller (PLC).

Q: Can work be performed on Saturdays?

A: Work on Saturdays will be permitted as needed for utility tie-ins, off-peak traffic conditions and other extenuating circumstances. All requests to work on Saturdays will need to be in writing and approved by the DPW and NHDOT (as part of the project is in their jurisdiction and will be written within the project permit).
