- 3. Each General Bid shall be accompanied by a Bid Security in the amount of 5% of the Total Bid Price.
- 4. The successful Bidder must furnish 100% Performance and Payment Bonds and will be required to execute the Contract Agreement within 10 days following notification of thee acceptance of his Bid.
- 5. No Bidder may withdraw a Bid within 30 days after the actual date of opening
- 6. This Contract contains price adjustments for hot mix asphalt mixes.
