3. Treasurer's Report

All account lines are funded, no concerns from Marie or Patty. Patty is following up about a particular trust account to ensure we get paid adequately. Brian (in personal communication to Pam) says that account has been idiosyncratic before, and that Patty has handled it before. Budget request for FY2022 has been placed. It came within the 2% cap that the city requires, will be discussed with City Manager next week, presented to City Council in April.

4. Friends of the Library Report

Candy, Bruce and Peg attended. Regular meetings are mostly resuming, still not many activities, mostly moral support. Kathy notes that the Friends are reviewing their support of museums since there's no revenue during this time.

Bruce attended 2021-01-04 meeting; he was asked, does the Library use volunteers? He answered: no, it's unionized, maybe some smaller libraries accept volunteers. Pam notes that the trick is finding something for the volunteer to do, since so many jobs require specialized knowledge. Also have to find staff time to train them. Most effective volunteers have worked in libraries previously.

Marie clarified that it is part of the bargaining agreement that we can't have a volunteer perform any work that a staff member might be paid to do. Example: we can't have volunteers read to children because we do Story Time, and we're paid to do that. We have to be very careful about volunteers.

Bruce adds: the Friends are looking into using an empty store front in downtown Rochester to advertise the Rochester Friends of the Library.

5. Communications from the Interim Library Director

Many programs going on, very full agenda this evening, we can't really go over them all. Curbside checkout, make it and take it, tax assistance, vaccine signup assistance – the Library has done a lot to accommodate the pandemic. We do have in-person use of computers,

newspapers, wifi, but not browsing. Marie and Peggy Trout have put together a proposal to reintroduce in-person browsing.

- Starting next Wednesday, Feb 17, the Library will add 5 browsing appointments per hour.
 Curbside continues; appointments for computer, copier, wifi will continue, same hours. See website for details.
- Several stages of increased opening are planned, with the next one to be evaluated for potential implementation in the middle of March.
- More discussion about continued expansion of these services will happen at upcoming Trustees meetings, and supported with articles on the website, posted at the Library, and provided to media outlets to publish as they see fit.

We close between 12-1 for cleaning on Saturday. We also leave a 15-minute buffer between appointments where we try to wipe down common surfaces. We also have a virtual book club going, run by Beth Nerbonne.
