#### **BIDDER'S QUESTIONS**

- Q.14 Item 6b On-site Contaminated Groundwater Disposal includes the cost of treating petroleum contaminated groundwater on-site and then discharging of treated water to a permitted discharge location approved by the Engineer. Measurement shall be by the gallon based upon flow totalizer readings using a flow meter approved by the Engineer. However on the Bid Form, Item 6B is shown to be paid as a Lump Sum item. Please advise on which Unit this will be paid for.
